A motion was made by Rob Jacobsen and seconded by Mike Gentle to approve extending Superintendent Williams contract by one year along with a pay freeze for FY15 as presented. All members present voted aye. Motion carried.

A motion was made by Mike Gentle and seconded by Rob Jacobsen to approve the Administrator salary freeze for FY15 as presented. All members present voted aye. Motion carried.

A motion was made by Mike Gentle and seconded by Rob Jacobsen to approve the support staff salary freeze for FY15 as presented. All members present voted aye. Motion carried.

A motion was made by Mike Gentle and seconded by Rob Jacobsen to approve the maternity leave and sick bank request of Lyndzi Craft as presented. All members present voted aye. Motion carried.
